The full coloring book can be found on the cooperative's website under the "Community" tab within the Youth Program section.



Leaders of tomorrow meet in Springfield



For more than 60 years, the electric and telephone cooperatives of Illinois have given tomorrow’s leaders the opportunity to learn from today’s public officials. Last month, more than 200 students from across rural Illinois represented 25 co-ops during Youth Day, including nine from Shelby Electric Cooperative (SEC).

“Youth Day gives students across the state an up-close look at democracy in action as they meet their elected representatives in Springfield,” said Faith Wheeler, who coordinates youth programs at SEC. “State senators and representatives have the opportunity to inspire and encourage the leaders of tomorrow during this annual event.”

In addition to meeting elected officials, the students also learned more about their electric or telephone cooperative’s role in their own communities and had the opportunity to tour the Illinois State Capitol and the Abraham Lincoln Presidential Library and Museum.

State Senators Doris Turner (D-48) and Steve McClure (R-54) and Representatives Brad Halbrook (R-107) and Wayne Rosenthal (R-108) met with nine students representing Shelby Electric Cooperative. These students included: Marley Phelps, Jack McClain, Maya Klotz, Alexander Lefever, Alexa Oliver, Lexi Marion, Collin Hewing, James Porter and Issabell Reed.

During lunch, Illinois Department of Natural Resources

Director Natalie Phelps Finnie addressed the students. She discussed her background as a healthcare provider and how she got into politics. She encouraged them to follow their passions, live confidently, and work hard.

“You’re embarking upon adulthood,” Phelps Finnie said to the students. “You can do anything you want to do. I just ask that you come to adulthood with the right posture and attitude. ... Don’t come with a sense of entitlement that everything is owed to you. Work for it. Earn it.”

Participants also met Paris Van Dyke, the 2023-2024 Illinois Youth Leadership Council representative, who was sponsored by Wabash Communications during last year’s Youth Day. She spoke about her experiences over the past year and challenged attendees to say, “Yes.”

“What I want to say to you today is something that I decided to do during this day last year — take every opportunity,” Van Dyke said. “You will learn so much if you just choose to say, ‘Yes.’”

At the end of the day, attendees were interviewed for the chance to participate in the annual Youth to Washington Tour sponsored by the Illinois electric and telephone cooperatives. This year’s trip will be held June 14-21. Jack McClain and Maya Klotz will represent Shelby Electric on the weeklong trip and meet their elected officials, see historic sites, learn firsthand how cooperatives work and gain valuable leadership skills. New summer hours announced!



Your cooperative will be implementing a new summer work schedule and hours of operation beginning **Monday, June 10, 2024.**

In an effort to streamline all business units, Shelby Electric Cooperative (SEC), Shelby Energy Company, and PWR-net will be open for business from 6:30 a.m. to 4:30 p.m. Monday through Thursday, with offices closed on Friday. This summer work schedule will be in effect from June 10 to August 9.

“This schedule is meant to achieve some workflow efficiencies for the cooperative and will also offer some flexibility to members to have an opportunity to come


in early in the morning or later in the afternoon to do business with us over the summer months,” said SEC President/CEO Josh Shallenberger. “If an outage comes up or something is required to be taken care of on a Friday, it will still be handled much as it is during a holiday or a weekend occurrence, so nothing changes there,” noted SEC Manager of Operations Terry Oldham.
